I. INTRODUCTION

1. Plaintiff Royce Mars brings this civil action for damages and equitable relief under the **Racketeer Influenced and Corrupt Organizations Act ("RICO")**, 18 U.S.C. § 1962(a)-(d), and related civil-rights statutes.

2. The Complaint concerns a **coordinated pattern of racketeering activity** between 2022 and 2026 **carried out under color of California state authority** by members of the Santa Clara County judicial network known as **Santa Clara Mafia Cartel (BBMP - Bench, Bar, Media and Police criminal syndicate)** and their private associates, resulting in:

- Kidnapping and unlawful detention of Plaintiff's son Max Mars,
- Extortion of passport, green card, all documents of Petitioner's kidnapped son Max Mars,
- Killing Hope, Petitioner's mom, 95 years old senior woman with disabilities,
- Unlawful seizure of Petitioner's assets and property, including Petitioner's 401(k), car VW Tiguan, \$200,000 seized through unlawful wages garnishment, fraud on court and extortion orders;
- Unlawful arrest and incarceration of Petitioner,
- Fabricated criminal and civil charges, arrest warrants,
- Obstruction of federal constitutional rights to due process and access to court.

II. JURISDICTION AND VENUE

3. This Court has subject-matter jurisdiction under 28 U.S.C. § 1331 (federal question) and 18 U.S.C. § 1964(c) (civil RICO).

4. Supplemental jurisdiction exists under 28 U.S.C. § 1367 for related state-law claims.

5. Venue is proper in the Western District of Texas because Plaintiff resides in Austin, Texas, and substantial effects of Defendants' racketeering conduct continue to harm Plaintiff here.

III. THE CRIMINAL ENTERPRISE

6. Defendants formed and participated in an **association-in-fact enterprise (the California Judicial Mafia Cartel, Santa Clara Mafia Cartel, known as BBMP - Bench, Bar, Media and Police criminal syndicate)**, consisting of certain California judges, including **homosexual presiding judges (Julie Emede, Beth McGowen, Theodore Zayner) biased in favor of homosexual pedofiles kidnapers**, disqualified family court judges (Stephen Lowney, Andrea Flint, James Towery), criminal court judges racketeers (Thomas Kuhnle, Benjamin Williams, Michael Clark), corrupt police officers racketeers (Chase Martin and Mutin, Sunnyvale PD), attorneys (Steven Dinneen, Nancy Roberts), state officials (Governor Gavin Newsom, Attorney General Rob Bonta), and **foreign associates including organized criminal group of aggressive Ukrainian homosexual pedofiles Sir Gay "Gondon" Nahornyy (Serhii "Gondon" Nahornyy), Ivan "Pedofile" Omelchenko - leaders of Ukrainian Mafia Cartel "Kodlo Gondona Nahornogo" ("SI Trans Group")**, who have documented history of racketeering, child trafficking, money laundering, extortion, unlawful seizure of assets and property, hostile takeover of businesses from their partner Serhii Rybalko through fabricated arrest warrants and criminal charges, fabricated by corrupt Ukrainian and California judges and police officers.

7. **Purpose of the enterprise:** to extort money and property, traffic Petitioner's son Max Mars outside of the United States to Ukraine into custody of Sir Gay "Gondon" Nahornyy (Serhii "Gondon" Nahornyy), his criminal associate Ivan "Pedofile" Omelchenko and daughter of Gondon Nahornyy, Hanna "Gnyda" Nahorna (Hanna "Gnyda" Mars), and to conceal judicial corruption by using California courts as weaponized racketeering instruments.

8. **Means and methods:** kidnapping, murder, extortion, coercion, unlawful arrests, threats of incarceration, fabrication of criminal records, bribery, fraud upon the court, fabrication of orders, targeted racketeering attacks, denial of access to California courts, and obstruction of federal proceedings.

IV. PREDICATE ACTS OF RACKETEERING

Each of the following constitutes a predicate act under 18 U.S.C. § 1961(1):

1. **Bribery & Extortion (18 U.S.C. §§ 1951, 201):** Judge Stephen Lowney allegedly accepted bribes from aggressive Ukrainian homosexual pedofiles Sir Gay "Gondon" Nahorny (Serhii "Gondon" Nahorny) and Ivan "Pedofile" Omelchenko, and during the 2/7/2024 hearing was using threats of unlawful incarceration to extort from Plaintiff Royce Mars his son's Max Mars passport, green card, and identity documents to facilitate **child trafficking schema of international abduction of Max Mars outside of the United States to Ukraine** into custody of Sir Gay "Gondon" Nahorny, Ivan "Pedofile" Omelchenko and daughter of Gondon Nahorny, Hanna "Gnyda" Nahorna (Hanna "Gnyda" Mars).
2. **Obstruction of Justice (18 U.S.C. § 1503):** Disqualified judges Stephen Lowney, Andrea Flint, and James Towery continued adjudicating case 22FL003144 after lawful disqualifications of them; while presiding judge Beth McGowen concealed their disqualifications and refused to remove Lowney, Flint and Towery from the case 22FL003144 despite publicly exposed and undeniable conflict of interest, and direct threats of malicious prosecution from Stephen Lowney and Andrea Flint reported to Beth McGowen.
3. **Kidnapping & Child Trafficking (18 U.S.C. § 1201):** Defendants jointly facilitated kidnapping of Petitioner's son Max Mars, are unlawfully holding Max Mars hostage without right for a contact or access to phone and internet, blocked all parental contact under legally void restraining orders, with the purpose of coercion to surrender custody rights and facilitation of international child trafficking of Max Mars outside of the United States to Ukraine into custody of aggressive Ukrainian homosexual pedofile Sir Gay "Gondon" Nahorny, Ivan "Pedofile" Omelchenko and daughter of Gondon Nahorny, Hanna "Gnyda" Nahorna (Hanna "Gnyda" Mars).
4. **Wire Fraud (18 U.S.C. § 1343):** Transmission of falsified financial documents by attorney Nancy Roberts to support unlawful extortion orders, and wage-garnishment by DCSS.

5. **Mail Fraud (18 U.S.C. § 1341):** Use of postal mail to deliver fraudulent court orders and wage-garnishment notices across state lines.
6. **Money Laundering (18 U.S.C. § 1956):** Transfer of funds extorted through DCSS to private accounts connected with the enterprise.
7. **Retaliation Against Witness (18 U.S.C. § 1513):** Unlawful arrests, issuance of arrest and bench warrants after Plaintiff filed federal complaints and judicial-disqualification statements.

These acts form a **continuous pattern of racketeering spanning multiple years and entities.**

V. INJURY TO PLAINTIFF

1. **Loss of custody** and companionship of minor child Max Mars.
2. **Unlawful seizure of approximately \$200,000 in assets** (401(k), wages garnishment, vehicle VW Tiguan, theft by Steven Dinneen, Mary Rolison, and paid supervisors).
3. **Destruction of employment and professional reputation.**
4. **Severe emotional distress and physical-security risks** due to unlawful arrests and ongoing unlawful arrest warrants.

VI. CAUSES OF ACTION

Count I - RICO § 1962(c): Conduct of Enterprise Through Pattern of Racketeering

Defendants, through their positions in the enterprise, conducted or participated in the affairs of the enterprise through the predicate acts listed above.

Count II - RICO § 1962(d): Conspiracy

Each Defendant conspired to further the racketeering enterprise by agreeing to its objectives and committing overt acts in furtherance of it.

Count III - Deprivation of Civil Rights (42 U.S.C. § 1983)

Defendants acting under color of state law deprived Plaintiff of constitutional rights to due process, equal protection, and access to court.

Count IV - Obstruction of Justice (18 U.S.C. § 1503 et seq.)

Defendants interfered with Plaintiff's access to federal review and concealed judicial disqualifications to obstruct justice.

VII. PRAYER FOR RELIEF

Plaintiff respectfully requests that this Court:

1. **Enter judgment in favor of Plaintiff** and against all Defendants, jointly and severally;
2. **Award treble damages** under 18 U.S.C. § 1964(c);
3. **Order restitution of all unlawfully seized assets and property;**
4. **Declare void and enjoin enforcement of all orders issued by disqualified judges** in cases 22FL003144, 22DV000779, and B2402220;
5. **Order immediate release and restoration of custody of Petitioner's son Max Mars;**
6. **Refer evidence of criminal conduct to appropriate federal prosecutors;**
7. **Grant any further relief** the Court deems just and proper.


